Our main areas of focus have been in the support of education and development of children, enabling and empowering children with special needs, providing health care and enabling community development in rural areas.

Centum believes in engaging with several well established and dedicated NGO's and other like minded organisations to meet its CSR objectives. We aim to fund pilot projects in the areas of skilling, Swatch Bharath Abhyayan, and other welfare schemes for marginalised communities by partnering with the Government and working on public private partnership projects towards effectively and transparently implementing these projects.

OUR CSR PROGRAM

Centum's CSR activities are/will be implemented through:

- External partners - with track records in the CSR area.
- Centum Academy - aims to address the skill deficit in the electronics sector by developing high end talent through advanced learning and industrial training to make them employable.
- Centum Foundation - aims to develop and implement educational, healthcare and infrastructure projects for marginalised sections of society.

CSR POLICY

Centum's CSR initiatives are presented at the annual planning and budgeting meet of the company and forms an integral part of the business plan annually. All projects are assessed under an agreed strategy and are monitored every quarter, measured against targets and budgets. Whenever necessary, midcourse corrections would be carried out. To measure the impact of the work done, a social satisfaction audit is carried out from time to time.

External partnerships -

Centum has established collaborative partnership with ~~well-known~~well-known organisations such as:

- Akshayapatra where Centum has adopted all the government schools in Yelahanka to provide midday meal for the school children.
- Mathru School for the blind in Yelahanka is being given financial support for educating and providing a healthy and clean environment for the children to live.
- Supporting the annual free surgery initiative by Sparsh Hospitals, for the physically disabled children as well as adults.
- Supporting an NGO "ProVision Asia" for people with physical disability in their wheel chair distribution and other initiatives.
- Actively promoting as a corporate, initiatives like the blood donation camps, immunisation programmes, aid to victims of natural calamities etc.
- Adopted a village in Telangana (Moinabad district) and funded the extension of a school building which started high school education in the new school building. Built a community centre for the village.

Centum Academy -

The Academy aims to partner with training institutes for ITI/diploma training of high school graduates in the electronics sector in order to provide them with the necessary skills required for gainful employment in the relevant industry. Through this initiative to begin with the company will train up to 100 qualified students in the first year and will help them find placements. We are in the process of doing a feasibility study to partner with a few diploma colleges/institutes in Bangalore to develop and support and enhance their existing curricula to train and certify in high end electronics manufacturing practices and also invest in developing facilities to run these programs.

As part of this initiative we intend to promote gender equality and empower women by allocating a percentage of the funding from the academy to skilling and training women for gainful employment in the specific sectors.

Centum Foundation.

Incorporation of Centum Foundation/ Centum Trust to route and drive all CSR initiatives of Centum is under consideration and planned to be incorporated. The foundations initiatives will primarily focus on Education, Healthcare, Sustainable livelihood, Infrastructure development and other social causes that would help improve the quality of life for the marginalised communities.



GOVERNANCE

CSR Committee:

The CSR Committee is responsible for oversight of all CSR activities from start to finish. It shall meet at least twice a year to ensure Centum delivers on its CSR goals.

The Committee comprising of the Directors of the "Centum Board of Directors" has been formed.

Identification of Programs for CSR:

Programs to be supported via CSR will be identified and selected by the CSR committee through a transparent process and the selected programs will meet the regulatory requirements.

Budgeting and Spend:

For each financial year, the minimum amount available for CSR spending will be defined in accordance with the applicable provisions of the statute. Any surplus arising out of CSR projects shall not form part of business profit of the company.

As per the statute, any unspent budget shall be reported in the annual report.

Reporting:
