Please note that the Fund Raising Committee of the Board of Directors of the Company ("**Committee**") has, at its meeting held today i.e. March 13, 2025, approved the allotment of 1,810,345 Equity Shares of face value ₹ 10 each to eligible qualified institutional buyers at the Issue price of ₹ 1,160 per Equity Share (including a premium of ₹ 1,150 per Equity Share) [and reflecting a discount of ₹ 59.65 (i.e.4.89%) per Equity Share on the floor price of ₹ 1,219.65 per Equity Share] against the floor price of ₹ 1,219.65 per Equity Share, aggregating to ₹ 2,100,000,200 (Rupees Two Hundred and Ten Crore Two Hundred Only), pursuant to the Issue in accordance with provisions of SEBI ICDR Regulations.

The Issue opened on March 10, 2025 and closed on March 13, 2025 and the same was intimated to you through our letters dated March 10, 2025 and March 13, 2025, respectively.

Further, we have enclosed herewith the list of allottees who have been allotted more than five percent (5%) of the Equity Shares offered in the Issue, marked as **Annexure A**.

Pursuant to the allotment of Equity Shares in the Issue, the paid-up equity share capital of the Company stands increased from ₹ 128,968,070, comprising of 12,896,807 Equity Shares of face value of ₹ 10 each to ₹ 147,071,520 comprising of 14,707,152 Equity Shares of face value ₹ 10 each.
